Talking Points for Leadership Calls

Re-districting:

- We anticipate redistricting is coming in the next couple of weeks (with maps being released possibly today or in the next few days)
- We anticipate that the map they are going to put out, given their need to pass it before the locals are done with their ward maps, is going to include political gerrymandering
- Our message is the process and the map is unconstitutional, political and

- partisan. It is not in the best interest of residents.
- We will be meeting as a caucus to talk strategy—we will need to keep our caucus strategy confidential.
- Please make sure there is no discussion of what democrats might do with anyone-especially press.
- In order to have the best chance, we will need to have a unified strategy with Senate Democrats, we will need to coordinate so we don't want to be commenting and speculating on problems with the GOP map prematurely.
- Remember--WE WILL NOT BE PASSING A MAP—everything we do is about positioning both from a message and legal perspective.
- We need to stick to the bigger picture message—the GOP map is yet another abuse of power, their map is unconstitutional, divisive and a blatant attempt to reduce accountability and secure political advantage for Republicans.
- We are working with the Senate, and Sen. Miller is having similar conversations with his members.

ONLY if people NEED to respond--Please stick to the message and the following specific redistricting points:

- · They should wait until the locals are done with their maps
- They should make sure the public has time to review
- They should make sure the public has access to process
- They should not put out a map that is unconstitutional and gives them a partisan advantage in 2012.
